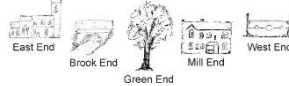

1. Welcome from the Chairman
2. To receive apologies for absence
3. To approve and sign the minutes of the meeting on 26 September 2022

6. Planning applications, planning enforcement and traffic orders

Alleged breach – Without permission a material change of use of:-
 - (i) the part of the land shown edged blue on the attached plan (formerly in agricultural use); and
 - (ii) the part of the land edged green on the attached plan (whose permitted use is as a farm shop with associated parking)
to a mixed agricultural and leisure attraction use, comprising café, restaurant, gift/farm shop, parking and lavatory facilities

 - b. 22/02659/LBC – Internal and external alterations to replace windows of front (north) elevation from Cruciform to Sash design – Lower Court Farm, Green End, Chadlington
– comment by 08 November 2022
 - c. OCC (Various roads – West Oxfordshire) (Prohibition and restriction of waiting and permitted parking)
“No waiting at any time” (to be signed as a restricted parking zone) parking prohibitions as follows:
 - A361 at Chadlington – both sides from a point 10 metres northeast of the junction with the access to Downs Hollow, south-westwards for a distance of 230 metres
 - Chipping Norton Road, Chadlington – both sides from its junction with the A361 Chipping Norton-Burford Road, south-eastwards for approximately 1370 metres- comment by 11 November 2022
 - d. Any planning applications or enforcement notices received before the date of the meeting
 - e. Update of previous planning applications and enforcement actions
