The content of the charter is purposely at a high-level, to enable all signatory parties to adopt the aims, principles and commitments within their own localities. All signatory parties will be invited to be a signatory to the charter at the launch of the final version in the spring.

All town and parish councils (including Parish Meetings) are invited to share their views on the draft charter, as well as all county, city and district councils. You can respond individually, or on behalf of your council/meeting.
