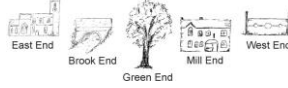

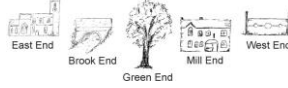

- It was noted that the Clerk will be taking annual leave in August.

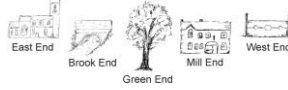
